Subject:- **ACCEPTANCE OF ADMISSION APPLICATIONS OF**
PAKISTANI STUDENTS WILLING TO TRANSFER
THEIR CREDITS FROM MEDICAL UNIVERSITIES OF
UKRAINE FOR THE ACADEMIC YEAR 2022/2023

This Mission has been approached by the Gomel State Medical University (GSMU) one of the leading medical university in Belarus vide their letter No.01-23/3258-2, dated 23 May 2022 (copy attached) whereby they have expressed the readiness to consider the grant of admission to the Pakistani students who have faced discontinuation in their medical studies owing to the situation in Ukraine.

2. The University has further conveyed that the transfer of credits for willing applicants from medical universities of Ukraine in the academic year 2022/2023 would be considered provided the students are able to submit their original senior secondary school examination certificates and academic transcripts in keeping with the regulations of the Ministry of Health and Ministry of Education of the Republic of Belarus. In the same vein, they have also indicated the possibility to have a prior analysis of curriculum difference and transfer of credits upon provision of the record book copies from respective universities of Ukraine.

3. In view of the above, it is requested to kindly disseminate / share the above information among the Pakistani students who are facing disruption in their studies as it might prove helpful in saving their careers. Furthermore, whereas the Belarusian universities maintain the high standards of education in their own right, being an ex-Soviet State, the curriculum and system of credentials award would

likely mirror those of the Ukrainian universities. However, it may kindly be noted that the GSMU would only consider the merits of applicant's case upon the provision of relevant record and academic certificates from the relevant Ukrainian Universities, they had erstwhile been studying at.

On behalf of the Administration of Gomel State Medical University (GSMU), I would like to express our sincere respect to the Embassy of the Islamic Republic of Pakistan to the Republic of Belarus. We would also like to inform Your Excellency that feeling the sympathy to the Pakistani students who had to discontinue their medical studies in Ukraine and now face a situation where their medical careers are at risk, the University has made a decision to accept admission applications of Pakistani students willing to transfer their credits from medical universities of Ukraine in the 2022/2023 academic year provided the students are able to submit their original senior secondary school examination certificates and academic transcripts reflecting complete data on studied subjects, exams and credits, number of theoretical and practical hours, obtained credits to the University at the time of their matriculation or within other time periods approved by the Ministry of Health and Ministry of Education of the Republic of Belarus.

Should the students fail to provide the above documents at the moment, prior analysis of the curriculum difference and transfer possibility may be done upon provision of their record book copies. In this regard, we would be very much obliged if the Embassy of the Islamic Republic of Pakistan could assist their nationals in obtaining the above credentials and other relevant

information from the Ukrainian medical universities to avoid document fraud and falsification and guarantee the students are aware and give their consent to cover the tuition fees and other fees related to academic work needed to be done extra to meet the degree requirements of the GSMU General Medicine MD program.
